

Showa Kinen Park Pet Owner Agreement

In entering the park with my pet, I hereby pledge to comply with the following rules.
Please review each of the following rules regarding pets inside the park and check each box with a tick mark ✓

<Regarding Rules for Bringing Pets into the Park>

- ☐ In principle, any troubles between visitors or between dogs inside the park (including the dog run) must be, resolved between the parties involved.
Furthermore, I will not seek the involvement of the park management.
- ☐ In the event that my pet causes injury to other visitors or staff, or causes damage to park facilities I will comply with claims for damages, regardless of the reason.
- ☐ I will not let my pet off their leash inside the park.
To avoid causing a nuisance to other visitors, I will keep the leash within 1.5 meters at all times.
- ☐ I will clean up and take home all waste, including trash and pet feces.
- ☐ I will not engage in any actions that harm the flora or fauna (plants and animals) inside the park (including the dog run).
- ☐ I will not occupy spaces for extended periods in areas where many visitors enjoy taking photos or viewing the scenery (such as flower fields) and I will cooperate improving manners to ensure that I do not cause any kind of nuisance to other visitors.
- ☐ My pet has received vaccinations for infectious diseases and on, all, within the past year.
For dogs, they have received a rabies vaccination and a combination vaccine (3-way or higher) within the past year. However, if they cannot receive vaccinations due to health reasons, or if they possess sufficient vaccine antibodies, I have obtained a temporary exemption certificate or an antibody titer test certificate issued by a veterinary hospital or a veterinarian within the past year.
- ☐ Some visitors to the park may not be comfortable around pets.
To ensure that everyone can have an enjoyable time, I will follow the established rules and instructions from staff, and I will cooperate improving manners.
- ☐ I agree that pets are not permitted to use the facilities listed below
 - Japanese Garden • Komorebi no Sato - Farmhouse Zone • Riding the Park Train
 - Walking pets alongside on the cycling course • Restaurants, shops and indoor facilities • Using rental boats
 - Using playground facilities and sports areas while accompanying pets

<Regarding Rules for Bringing Pets into the Dog Run>

- ☐ I agree to present proof of a rabies vaccination and a combination vaccine (3-way or higher) received within the past year when using the dog run (If vaccinations cannot be administered due to special reasons, you may still enter the park with a temporary exemption certificate or an antibody titer test certificate issued by a veterinary hospital or a veterinarian within the past year. Please notify the dog run staff upon entry).
- ☐ I will follow the established rules and instructions from staff at the dog run, and cooperate improving dog run manners.

Please note that if you do not follow the rules mentioned above, you may be denied entry or asked to leave the park.
In such cases, please be advised that no refunds will be given for admission fees, parking fees, or any other charges.
